At this time we are only conducting a feasibility study to determine if a restoration project is worthwhile. Should the project be determined feasible and the county decides to move forward with restoring portions of Crabtree Swamp, this should not affect your property since no work is proposed in the vicinity of your residence. In fact, the majority of work would be conducted below El Bethel Road.

The U.S. Fish and Wildlife Service (Service) has received your letter requesting the Service's involvement as a Cooperating Agency for the Crabtree Swamp Aquatic Ecosystem Restoration Feasibility Study (Study) in Horry County, South Carolina. The U.S. Army Corps of Engineers (USACE), along with Horry County, has initiated the Feasibility Study under Section 206 of the Water Resources Development Act in order to develop restoration alternatives for Crabtree Swamp. The USACE will be preparing an Environmental Assessment (EA) pursuant to the National Environmental Policy Act of 1969 (NEPA).

The USACE has requested the Service to serve as a Cooperating Agency for the Study. We appreciate your solicitation to be involved with the Study at this level. However, we believe it is more prudent to engage as a Participating Agency. Current staffing deficiencies coupled with an intense Regional focus on the evaluation of species deemed at-risk and the recovery of currently protected threatened and endangered species limit our availability to contribute to the Study.

The Service's participation will be specifically limited to: (1) participating in coordination meetings; (2) consultation on any relevant technical studies that may be required for the project; and (3) provide timely review and comments on the environmental document to reflect the views and concerns of our agency on the adequacy of the document, alternatives considered, and the anticipated environmental effects.
