C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland boundaries were established by the 1987 Wetland Delineation Manual. The wetlands, both Wetland 1 & Wetland 2, were determined to be isolated. These depressional wetlands exhibited hydric soils, hydrophytic vegetation, and the appropriate amount of wetland hydrology to satisfy the three criteria of wetlands. Both wetlands within the project area were determined to be isolated due to the following reasons. Although the wetlands met the criteria set forth in the 1987 Wetland Delineation Manual and the 2009 Coastal Plain Supplement, all of the water located within or draining toward this wetland has no discernible or traceable outfall which would connect it to other Waters of the US. Additionally, the wetland in review was found to be isolated as they are primarily encompassed by uplands (due to lack of hydrology) which disrupt any possible connection to other Waters of the US. Chemically the wetland does not affect any waters of the US in adsorption / treatment of nutrients, runoff, and pollutants. Physically, the topographic location of the wetland and its relation to other jurisdictional waters of the US is such that water in this wetland is retained and eventually percolated through the soil to groundwater only, to an unknown depth, providing a limited amount of stormwater attenuation. The site is approximately 1600 linear feet from the nearest WOUS (Cold Water Branch).

Located onsite are two isolated wetlands (Wetland 1 / 0.08 acres & Wetland 2 / 0.64 acres) totaling 0.072 acres with no connection to other WOUS.
