The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 12.49 acre tract that contains approximately 0.45 acres of jurisdictional freshwater wetlands that directly abut an on-site pRPW (approx. 570 linear feet). Limits of wetland boundaries were established by the 1987 Wetland Delineation Manual. Wetlands on-site were determined to be contiguous and directly abutting the on-site pRPW. Wetlands on site are bisected by the OHWM of the on-site pRPW. No natural or man-made barriers were observed between the wetland and the pRPW. This results in a direct hydrological, chemical, and biological connection between the wetland and the pRPW was determined to have perennial flow based on site visits conducted, within normal to below average rainfall conditions, on December 6, 2014 and on March 25, 2015 which revealed flowing water within a defined bed and bank. Geomorphic indicators of perennial flow include a firm sandy bottom clear of vegetation and debris with cut banks and point bar deposition adjacent to the channel. Hydrologic Indicators, in addition to observed flow, included an open channel with even distribution of substrates and the presence of organic drift lines. The presence of 100 % hydirc soils on the Soil survey and palustrine forest on the National Wetlands Inventory are similar in location as to that of the wetland and RPW on-Site. Wetland soils on site were saturated and met the S7 hydric soil indicator. Upland soils on-site lacked any evidence of hydrology and had high Chroma and value .
