The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 3.252 acre tract that was determined to consist entirely of uplands. The USGS topographic survey information located within Lucknow quad depicts the project area as non-forested uplands that contain buildings and that do not contain any blue line features or other symbols that would typically represent a water of the United States. Lee County soil survey information depicts the project area as being comprised entirely of Fuquay Sand. Fuquay Sand is a well-drained non-hydic soil. The NWIs depict the project area as being comprised completely of uplands. A review of aerial photographs depicts the project area as cleared uplands that contain a residential property. There are no features visible in aerial photographs that would indicate the presence of a water of the United States. Based on the consistent depiction of uplands throughout the NWIS, USGS topographic maps, Lee County soil survey information, and aerial photographs, the project area was determined to be void of any aquatic resources.
