**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The area in review contained no Waters of the U.S. or wetlands (isolated or adjacent). All soil samples consisted of non hydric soils, with little to no moisture throughout the column, and the vegetation was marginal facultative. All indicators onsite point to a well drained, upland site with little to no slope. Horry county NWI data depicts the majority of the site as U42P (upland planted pines) and a small portion of the site as PFO1/4B (forested palustrine wetland). No portion of the site exhibited wetland hydrology as observed in the field during the site visit. The project site is approximately 3500 linear feet from the nearest jurisdictional feature as depicted on USGS topographic maps. USGS topographic information and aerial photography depict the site as being a well drained forested upland area adjacent to a developed housing community and golf course.

No ditches or potentially jurisdictional features were observed during the site visit.

SAC-2010-014073JY (Tract A) & SAC-2014-01408-3JY (Tract B) were combined into the project area for this review. Each of these two projects were determined to be uplands in letters dated June 13, 2011. In addition, a letter dated August 21, 2009 (SAC-1999-38325-3JC), determined an adjacent parcel to be uplands that shared the same soil, hydrology, and vegetation characteristics. The site in review was separated as an outparcel of this tract.
