C. SIGNIFICANT NEXUS DEIERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. B. ADDITIONAL COMMENTS TO SUPPORT JD: Project area is comprised of 29.11 acres. Of that 29.11 acres only 20.86 were evaluated in this determination. The reason for this is that the referenced tract contains 8.25 acres protected by Restrictive Covenants under Department of the Army permit SAC#2003-04737-3NI. These 8.25 acres depicted as "PROTECTED AREA UNDER SAC-2003-04737-3NI REF PLAT #9" on the above referenced plat were not reviewed and therefore not included in this determination. Of the remaining 20.86 acres, 0.21 acres have been determined to be waters of the United States (TNW), the Atlantic Ocean.
