visit, water was flowing from the wetland to the off-site RPW through this non-jurisdictional drainage. The water was the result of the recent, record breaking rainfall in the area. Summarize overall biological, chemical and physical functions being performed: **This wetland is performing functions that relate to the biological, chemical, and physical integrity of the nearby TNW. The water discharging from this wetland flows to an Unnamed Tributary of Lake Murray which is a Navigable Water of the U.S. and a Traditional Navigable Water. This wetland is located in an area that is currently being developed. It provides habitat for wildlife in the area and breeding grounds for aquatic species. It also helps to filter pollutants and run-off from nearby development before it travels downstream to the nearby TNW. This wetland helps to store flood water during times of heavy rain and in the wetter months. This was observed during the site visit.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
