C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland boundaries established by the 1987 Wetland Delineation manual. The 0.01 and 0.02 acre wetlands in the review area meet all three wetland parameters and were inundated at the time of the site visit. Additionally, thsee wetlands discharge directly into the Atlantic Ocean by way of the stormwater system.

During the site visit water was obsered discharging from the onste wetlands into the stormwater drainage system of the town of Surfside Beach. While tracing this stormwater system in the field, a noticable increase in the volume of water and velocity was observed prior to its discharge directly into the Atlantic Ocean north of the intersection with 4th Avenue and North Ocean Boulevard.

This site was assessed on one basis form
