C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: After researching the best available information (i.e. previous JD's, aerial photos, topographic maps, soil survey information, and NWI maps), it was determined that a desktop review could be performed for

this determination request. The site is mapped as uplands (U42P) on the NWI maps. There are no aquatic resources (wetlands or tributaries) depicted on topographic maps and there are no signatures indicative of aquatic resources on aerial photos. The soils on this property are mapped as Ogeechee, which is a hydric soil. However, the adjacent property, which is also mapped as an Ogeechee soil, was previously determined to be uplands (SAC# 2014-00976-3B, letter dated 12/2/2014). A site visit was performed on the adjacent site on October 10, 2014 and was determined to consist of non-hydric soils throughout the entire property. There is no evidence that supports hydric soils existing on the subject property in questions. Therefore, it was determined that the subject property (Sierra Woods Phase II) consists entirely of uplands.
