C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Florence County Soil Survey information depicts the project area as being comprised of a combination of Wagram sand, a well drained partially hydric sand, and Pocalla sand, a somewhat excessively drained non-hydric sand. The majority of the project area is mapped Pacalla. A small inclusion of Wagram is depicted protruding from the western project boundary, however based on aerial photographs this area is an agricultural field. NWIs depict the project area as entirely upland cropland and pasture. Aerial photographs depict the project area as an agricultural field that does not contain any signatures that would typically represent a WOUS. The project area contains a small wooded area along the southern property boundary. A data point and site photos taken within the wooded area document this area as containing non-hydric soils and lacking any indicators of hydrology. Due to the consistent depiction of uplands throughout all of the available desktop resources to this office this track was determined to consist entirely of uplands.**
