C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

NRCS WETS tables show that the average annual rainfall in this area is approximately 46.9". At the time of the site visit this area had received 52.87" of rain over the last year (March 2014 –March 2016). That is 5.97" above average and 2.83" outside the range of normal.

- B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 1 acre lot located in Darlington County that was determined to consist entirely of uplands. A site visit conducted on 4/12/16 revealed that this site did not contain any hydric soils or any indicators of hydrology during a period of above average rainfall. Soils on-site had high chroma and value and no water was observed in a 3-4' deep pit that had been excavated out of the wood area near the western project boundary. The potential wetland onsite did not meet the required criteria set forth in the 1987 delineation manual for identification of a wetland and therefore this site is determined to consist entirely of uplands.**
