water pond with no vegetation growing in it. As stated in the Preamble to the November 13, 1986, Regulations found on page 41217 (Federal Register vol. 51 No. 219) "water-filled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and resulting body of water meets the definition of waters of the United States" are generally not considered waters of the U.S. For these reasons, the stormwater pond was determined to be non-jurisdictional.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Wetland A (43.76 acres) and Wetland B (10.22 acres) were determined to be jurisdictional and therefore subject to regulation under Section 404 of the Clean Water Act.

It was dug from uplands and is an open water pond with no vegetation growing in it. As stated in the Preamble to the November 13, 1986, Regulations found on page 41217 (Federal Register vol. 51 No. 219) "waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and resulting body of water meets the definition of waters of the United States" are generally not considered waters of the U.S. For these reasons, the stormwater pond was determined to be non-jurisdictional.

jurisdictional. Wetland G (0.31 acres) is an isolated, depressional wetland that sits approximately 2-3 feet lower in the landscape than the surrounding uplands. Wetlands I (0.06 acres) and Wetland J (0.29 acres) are located in the northeast corner of the property near the highway and are also isolated depressional wetlands that are approximately 1-3 feet lower in the landscape than the surrounding uplands. Both of these are bound on all sides by development and roads. They receive surface runoff from the surrounding uplands, development, and highway, but have no outlet except through evapotranspiration. All three of these small wetlands do not have any physical hydrologic outlet and no apparent connections to waters of the U.S., including no physical, chemical, or biological connections. In addition, there was no apparent ecological interconnectivity with other water features, including any waters of the U.S., and no apparent connection to interstate or foreign commerce. Therefore, Wetlands G, I, and J were all determined to be non-jurisdictional, isolated wetlands and are not subject to regulation under Section 404 of the Clean Water Act.

Wetland G (0.31 acres) is an isolated, depressional wetland that sits approximately 2-3 feet lower in the landscape than the surrounding uplands. Wetlands I (0.06 acres) and Wetland J (0.29 acres) are located in the northeast corner of the property near the highway and are also isolated depressional wetlands that are approximately 1-3 feet lower**

in the landscape than the surrounding uplands. Both of these are bound on all sides by development and roads. They receive surface runoff from the surrounding uplands, development, and highway, but have no outlet except through evapotranspiration. All three of these small wetlands do not have any physical hydrologic outlet and no apparent connections to waters of the U.S., including no physical, chemical, or biological connections. In addition, there was no apparent ecological interconnectivity with other water features, including any waters of the U.S., and no apparent connection to interstate or foreign commerce. Therefore, Wetlands G, I, and J were all determined to be non-jurisdictional, isolated wetlands and are not subject to regulation under Section 404 of the Clean Water Act.
