C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

of the year under normal climactic conditions. Stream geomorphic indicators of perennial flow include a defined channel within a bed and bank which had a firm sandy bottom clear of vegetation and debris. Hydrologic indicators included observed flow, organic drift linea and the presence of iron oxidizing bacteria. Biological indicators included the presence of schools of fish. Additionally the tributary is depicted as a blue line feature situated in a naturally low lying drainage area on USGS topographic maps. Aerial photographs depict the signature of a defined channel. The feature is depicted as a riverine system connecting wetlands on NWIs and Soil survey information depicts the feature as being located within hydric soils. This feature flows into Jefferies Creek which flows into the Great Pee Dee River, a TNW.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 3.51 acre tract that was determined to contain 339 linear feet of tributary with flow at least 90% of the year under normal climactic conditions. This determination was based on observations in the field including but not limited to observed flow, firm sandy bottom, fish, iron oxidizing bacteria, continuous OHWM, and a defined channel within a bed and bank. This feature flows into Jefferies Creek wich flows into the Great Pee Dee River, a TNW. Potential wetlands on site did not meet the criteria set forth in the 87 manual for the identification of wetlands. Specifically soils did not meet any hydric soils indicators due to high chroma and the presence of greater than 30% uncoated sand grains and hydrology indicators were not present on-site during a period of normal to above average rainfall. One non-jurisdictional ditch is located on site. This feature was determined to have been excavated out of uplands and did not contain any indicators of flow. .
