Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The 0.77 wetland within the 2.25 acre review area was determined to be isolated and non-jurisdictional. In addition to utilizing remote resource tools to include the USGS topographic map and historical aerial photographs found on Google Earth Pro a site visit was completed. The wetland sits in a depressional pocket within the landscape and is surrounded by uplands. The wetland appears to have been isolated from surrounding waters within the watershed by the construction of the Ashley Phosphate Road, the Palmetto Commerce Pkwy, and a railroad line. The wetland has no apparent physical, chemical, or biological connection to waters of the U.S., and has no apparent surface or shallow subsurface hydrologic connects to waters of the U.S. In addition, the wetland has no connection to interstate or foreign commerce.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on the above information it has been determined by this office that the 0.77 acre wetland is an isolated, non-jurisdictional water that is no subject to regulation under Section 404 of the CWA.
