C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

a review of the aeriels, soil survey, NWIs, and LIDAR. Although the tributary is not depicted on the topographic map, it is depicted as a shaded linear feature on the aeriels. The downstream portion of this tributary is mapped palustrine forested wetlands (PFO1/4B) and the entire length of this tributary is mapped Coxville, a hydric soil, on the soil survey. The LIDAR depicts this tributary as a sinous channel within bed and banks that continues north into Chinners Swamp. Chinners Swamp flows west into the Little Pee Dee River, a TNW.

The NWIs map this wetland as palustrine forested (PFO1B) and the soil survey maps this wetland system and tributary as Meggett, a hydric soil.

The Jurisdictional Impoundment was determined to have been excavated out of Jurisdictional Wetland C. The aerials depict this impoundment as located immediately adjacent to Jurisdictional Wetland C, and the LIDAR shows this impoundment as an open waterbody abutting Wetland C. This impoundment is mapped Palustrine Unconsolidated Bottom on the NWIs and is surrounded on the east and south by palustrine forested wetlands.

The off-site tributary located south of the project site was determined to flow year round based on a review of the aerials, soil survey, and LIDAR. Although the tributary is not depicted on the topographic map, it is depicted as a shaded linear feature on the aerials. The entire length of this tributary is mapped Meggett, a hydric soil, on the soil survey. The LIDAR depicts this tributary as a sinous channel within bed and banks that continues south into Brunson Swamp. Brunson Swamp flows west into the Little Pee Dee River, a TNW.
