jurisdictional. The wetland is 0.88 acre in size and is surrounded completely by uplands. No ditches or swales are present coming out of the wetland. A portion of the wetland is bordered by the road right-of-way for Ladson Road. No roadside ditch is present at this location and no culvert was found to be located within the right-of-way that would connect the wetland to properties and wetlands across the street. The area directly across the street from the subject project review area was observed from the road and no ditches or wetlands were present. With regards to the subject wetland, there was no evidence of a discrete surface hydrologic connection through the uplands, no apparent shallow subsurface hydrologic connection, and no apparent physical, chemical, or biological connection, to waters of the U.S. In addition, the wetland has no apparent ecological interconnection to waters of the U.S. For these reasons, the wetland was determined to be isolated and non-jurisdictional, therefore not regulated by Section 404 of the CWA.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
