banks or channel with OWHM was observed within the project boundary. Therefore, this area was determined to consist of uplands.

A second area shown as wetlands by the agent was viewed. This area is located near the southern portion of the site and is depicted as Coxville, a hydric soil, on the soil survey, but is not depicted on the NWIs or topographic map. This area was investigated during the site visit and was determined to have non-hydric soils and no indicators of hydrology. Although this area had bed and banks, no channel or OWHM was observed within this feature. Therefore, the agent was notified that this area should be depicted as a non-jurisdictional ditch on the drawing.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
