**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form addresses 10.25 acres of which 0.4868 acres are jurisdictional (RPW) in Conway, SC. The RPW is known as the CCC Canal. Based on a previous site visit (SAC-2012-01116-3B) the CCC Canal along the northern property boundary was determined to be a perennial RPW with flow at least 90% of the year. SGS topographic survey information depicts an upland forested area void of wetland symbols with a solid blue line bounding the northern project boundary. The project area is comprised of hydric soils Leon, Lynn Haven, and the partially hydric soil Echaw. NWI maps map the project area as uplands and the pond on site is mapped as open water (PUBHX). The pond was determined to be an upland excavated non-jurisdictional pond.
