Some upland excavated ditches did dsiplay an OHWM, however all upland excavated ditches (not identified as RPWs) lacked indicators to support a relative permenant flow of water. In addition, the site contains one made-made non-jurisdictional pond that was determined to be excavated from uplands.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. In addition to site inspection other resources were reviewed which included Topographic maps, aerial photos, Horry County Soil Survey, and 1975 Horry County Drainage Study. Topographic maps do not depict a tributary; aerial photos depict signatures of a drainage feature; Horry County Soil Survey does depict a tributary within this area where tributary is located.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The tributary, considered man-altered, was determined to be an RPW with perennial flow. The site visit was performed under severe drought conditions. Water was observed flowing within the onsite tributary at the time of site visit. Hydrologic indicators observed within the onsite tributary were; a well defined channel clear of terrestrial wegetation and debris, even distribution of substrates (longitudinally), deposition bars, litter and debris on the banks of tributary. Limits of jurisdiction for tributary was established by a well defined OHWM. Limits of jurisdiction of wetlands were established by the 1987 Delineation Manual and Regional Supplement. Wetlands were determined to be directly abutting/contiguous to the RPW. Flow of onsite tributary is to an offsite tributary that outfalls directly into the TNW Waccamaw River.

In addition, the project area contains several upland excavated non-jurisdictional ditches. A portion of the upland excavated ditches did display an OHWM; however, all lacked indicators required to support a determination of a relative permenant flow of water (RPW). The remaining ditches lacked both an OHWM and indicators of relative permenant flow of water. Since some of these linear features do not display an OHWM and all lacked indicators to support a relative permenant flow of water, they were determined not to be a WOUS.

Potential wetlands within the project area consisted of hydric soils, however, lacked both hydrology and hydrophytic wegetation. The Site has been previously altered by several ditches that have effectively altered the hydrology of the Site. A review of the US EPA "Consent Agreement and Final Order" dated September 26, 2013, and the Corps' previous Jurisdictional Determination dated December 13, 2010, revealed the onsite ditches have effectively altered approximately 40 acres of onsite wetlands (more details are provided in regards to site alterations in the "Consent Agreement and Final Order dated September 26, 2013).

Finally, the project area contains one upland excavated pond. This upland excavated pond was determined not to be associated with any WOUS and therefore not an impoundment of a waters of the U.S.
