C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Documentation for the Record only: Significant nexus findings for seasonal RPWs and/or wetlands abutting seasonal RPWs: The seasonal tributary located on the site is performing a variety of functions related to the biological, chemical, and physical integrity of the downstream TNW. This tributary is located on a site that is mostly forested. It provides breeding ground and foraging areas for aquatic species. It also provides habitat for wildlife in the area. The site is mostly forested but is located near some development. This tributary helps to capture runoff from uplands and pollutants from the development and filter them before they head downstream. This tributary also helps to perform flow maintenance by storing flood and rain water before it flows downstream. Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the downstream TNW (Thurmond Lake), it has been determined there is a significant nexus between the relevant reach of the tributary to the downstream TNW.
