forested uplands on the topographic map. During the site visit, a data point was taken near the center of this 1.34 acre site. The site was determined to be void of hydric soils and to lack indicators of hydrology. Therefore, the entire site was determined to consist entirely of uplands.

A linear feature was observed at the western property boundary during the site visit. This feature is not depicted on the aeriels or topographic map. The feature is straight and had dry leaf litter and debris in the bottom. Due to the lack of flow indicators including an OHWM, this feature was determined to a non-jurisdictional ditch.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
