**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The project area addressed in this form contains approximately 3.2 acres that are located completely within the right of way of an existing SCDOT roadway which is determined to consist entirely of uplands. The project area is comprised of a portion of Daniels Road in the City of Lake City. The USGS topographic survey information located within Mill Bay quad depicts the project area as being located along established SCDOT roadways within the City of Lake City. There are no blue line features or other symbols that would typically represent a water of the United States located within the boundaries of the project area. A solid blue line feature is depicted to the southeast of the project area however Florence County LiDAR shows that this feature terminates outside of the boundaries of the project area. The NWI depicts the project area being comprised of residential and agricultural uplands. A small depressional , partially drained wetland is depicted to the southeast of the project area however a review of aerial photographs and Florence County LiDAR data reveals that this feature does not exist within the boundaries of the project area. Although the project area is depict as containing hydric soils a review of aerial photographs reveals that the project area is located within the right of way of an existing road way. There are no features within the boundary of the project area that would typically indicate a water of the U.S. Due to the consistency in the depiction of uplands throughout USGS topographic information, NWI maps, and aerial photographs, the project area was determined to be void of any aquatic resources.
