**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form addresses a 5.80 acre tract that contains 2.44 acres of wetlands that were determined to have a significant nexus to Collins Creek in Approved JD SAC 2016-00437-3B issued on August 3, 2016 and Approved JD SAC 2005-41222 (f.k.a. 2005-0575) issued on November 1, 2010. Limits of jurisdiction were established by the parameters set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement. Wetland boundaries were verified using a combination of aerial photographs, data sheets, site photos, and information gathered by the Corps during a site visit conducted on May 19, 2016 as part of a potentially unauthorized activity investigation. The flow route from the wetlands to the downstream TNW was documented in Approved JD SAC 2005-41222 as follows, "The Team identified the flow route from the wetlands on the site to Collins Creek, a traditional navigable water (TNW), to be from an adjacent pond which discharges into a roadside ditch (Lee Circle) that discharges into a culverted storm water conveyance through residential lots, ultimately to an open ditch that traverses the wood line behind a commercial development(Suck, Bang, Blow Bar) that discharges into un-named Tributary 1 (a Relatively Permanent Water or "RPW"). Tributary 1 flows to un-named Tributary 2 (RPW) that flows to un-named Tributary 3 (RPW) that flows to un-named Tributary 4 (RPW) that flows to Tributary 5 (RPW Collins Creek-above tidal influence and non-navigable) that flows into a TNW (Collins Creek tidal and navigable) where waters are subject to the ebb and flow of the tide." .
