determined to be isolated and non-jurisdictional. It is approximately 0.20 acres and sits 3-4 feet lower in the landscape than the surrounding uplands. It is bound on all sides by uplands and is adjacent to a residential subdivision and commercial development. It was a depressional feature with no outlet except through evapotranspiration. It does not have any physical hydrologic outlet and no apparent connections to waters of the U.S., including no physical, chemical, or biological connections. In addition, there was no apparent ecological interconnectivity with other water features, including any waters of the U.S., and no apparent connection to interstate or foreign commerce. Therefore, the wetland in question was determined to be a non-jurisdictional isolated wetland and is not subject to regulation under Section 404 of the Clean Water Act.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
