C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

ADDITIONAL COMMENTS TO SUPPORT JD: The depressional area onsite was determined to meet the three parameters for the identification of a wetland as outlined in the 87 manual however it appears that water that enters the wetland is confined within the wetland and leaves only through evaporation or percolation to an unknown depth. The onsite wetland directly abuts an offsite roadside swale, however, a site visit conducted on 8/2/17 revealed this feature increased in elevation and eventually bottomed out in both directions. This feature does not provide a hydrologic connection between the wetland on site and any other WOUS. .

The site in question also contains 1 Jurisdictional wetland which is addressed on Basis Form 2 of 2 of this determination. .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. Horry County LiDAR, soil survey information and USGS topographic maps. Aerial photos depict a well-defined channel with uninterrupted flow into the Kingston Lake and then the Waccamaw River, the USGS topographic maps depict a solid blue line feature which is the symbol for perennial flow, Horry County soil surveys depict 100% hydric soil found most often in stream terraces, Horry County LiDAR depicts low elevations and a defined channel. Based on the previously mentioned evidence, this perennial RPW was determined to have flow at least 90% of the year under normal conditions. The wetland evaluated in this determination is contiguous and abuts the perennial RPW. There were no public access points along this portion of the perennial RPW there for field verification was not possible.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a site that contains a 0.24 acre jurisdictional wetland. Limits of jurisdiction were established by the parameters set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement. The area in question is situated in a naturally low lying drainage area mapped as saturated palustrine forest on NWIs and is separated from uplands by an obvious topographic break. The onsite wetland continues off site to the north and abuts and offsite perennial RPW which flows into the Waccamaw River, a TNW. This RPW was determined to be perennial using desktop resources including NWIs, Soil survey information, LiDAR, topo maps, and Aerial photographs.

One isolated non-jurisdictional wetland is located on site and is addressed on Basis form 1 of 2 of this determination.
