the review area were found to be isolated due to their separation from other waters of the US. These wetlands are completely encompassed by a uplands soils lacking appropriate hydrology. The wetlands is approximately 1500 linear feet from the nearest jurisdictional feature and is seperated by a housing development and Legends golf course. Chemically these wetlands does not affect any water of the US in the absorption / treatment of nutrients, runoff, and pollutants. Physically, the topographic location of these wetlands and thier relation to other jurisdictional waters of the US is such that water in these wetlands is retained and eventually percolated through the soil to groundwater only, to an unknown depth, providing little if any storm water attenuation. The primary source of hydrology in these wetlands is surface water / runoff from the adjacent areas. An examination of aerial photography, Horry County LIDAR data converted to 1 foot elevation contours. NWI wetland maps, and Horry County Soil Survey information concur that the wetland is cut off from other waters of the US physically, and chemically.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Four onsite wetlands (Wetland A / 1.03 ac + Wetland B / 0.94 ac + Wetland C / 0.91 ac + Wetland D / 0.32 ac = 3.20 acres) were determined to be isolated (non-jurisdictional). Because of the lack of discernable outfall, topography grades, surrounding infrastructure, and lack of evidence of chemical or biological connection, the wetlands were determined to be isolated non-jurisdictional and not connected to any other water of the U.S. Topographic maps depict no wetland symbols. No linear features (i.e. blue lines) were depicted on the topographic maps in the vicinity of the isolated wetlands. The primary source of hydrology in these wetlands is surface water / runoff from the adjacent areas. An examination of aerial photography, Horry County LIDAR data converted to 1 foot elevation contours. NWI wetland maps, and Horry County Soil Survey information concur that the wetland is cut off from other waters of the US physically, and chemically.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland boundaries were established using the 1987 Wetland Delineation manual and Coastal Plain Regional Supplement. The onsite jurisdictional wetland contained the appropriate hydrology, hydrophytic vegetation and hydric soils to be determined a wetland. Additionally, this wetland continues offsite and is eventually bisected by a perennial RPW. It was determined that the offsite tributary flows at least 90% of the year under normal climatic conditions. The stream geomorphic indicators of perennial flow was a channel within the bed and banks visible from aerial imagery. In addition, other hydrologic indicators depicted on USGS topographic maps, such as a solid blue line, indicate perennial flow. Aerial photos depict a signature of a defined channel discharging into the Waccamaw River, Topographic maps depict a symbol (solid blue line) which represents a tributary with perennial flow, Horry County Drainage Canal Study depicts a main drainage canal (M-1) which represents a tributary with perennial flow.**
