jurisdictional. The wetland is approximately 0.07 acres in size and is located east of U.S. Highway 21. It consists of a concave, depression hardwood forested wetland and is surrounded by uplands/industrial development. It receives runoff from these areas, but its only outlet is through evapotranspiration. It does not have a physical hydrological connection or apparent subsurface connection, nor apparent ecological interconnectivity, to any waters of the US. There is also no apparent connection to interstate or foreign commerce. Therefore, this wetland was determined to be non-jurisdictional and not subject to regulation under Section 404 of the CWA.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Jurisdictional Wetland B meets the three parameters of wetland. In addition, it appears that this tributary drains an approximately 0.5 square mile area, obtaining hydrological inputs from surrounding wetlands within the approximate drainage area, as well as from upland runoff also in the drainage area. The tributary appears to flow approximately 500 linear feet where it discharges into a larger, named tributary, Crum Branch, carrying perennial flow. Crum Branch perennially flows for approximately 4 miles, where it discharges into another perennial tributary, Cow Castle Creek. Cow Castle Creek perennially flows for approximately 14 miles where it discharges into another perennial tributary, Four Hole Swamp. Four Hole Swamp perennially flows for approximately 31 miles where it discharges into a Traditionally Navigable Water (TNW), the Edisto River. Therefore, it is determined that Jurisdictional Wetland B is a jurisdictional wetland and is subject to regulation under Section 404 of the CWA.
