C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Photos depict a well-defined channel free of leaf litter and debris with continuous ordinary high water mark, the USGS topographic maps depict a solid blue line feature which is the symbol for perennial flow, Horry County soil surveys depict Leon soils which is a 100% hydric soil. Horry County LiDAR depicts low elevations and a defined channel. The tributary was determined to be a RPW with perennial flow in approved JD SAC 2006-01678-3JB issued on 9/14/2011. NWIs depict a riverine feature at the location of the RPW. Based on the previously mentioned evidence, this perennial RPW was determined to have flow at least 90% of the year under normal conditions. .

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 129.3 acre tract that was determined to contain approximately 2,145 linear feet of tributary with perennial flow. The tributary was determined to be a RPW with perennial flow by review of site photographs submitted by the agent, Horry County 2009 LiDAR, soil survey information, NWIs, previous jurisdictional determinations and USGS topographic maps. Photos depict a well-defined channel free of leaf litter and debris with continuous ordinary high water mark, the USGS topographic maps depict a solid blue line feature which is the symbol for perennial flow, and Horry County soil surveys depict Leon soils which is a 100% hydric soil. Horry County LiDAR depicts low elevations and a defined channel. The tributary was determined to be a RPW with perennial flow in approved JD SAC 2006-01678-3JB issued on 9/14/2011. NWIs depict a riverine feature at the location of the RPW. Based on the previously mentioned evidence, this perennial RPW was determined to have flow at least 90% of the year under normal conditions.

The site in question contains approximately 5.66 acres of upland excavated ornamental ponds that were determined to be non-jurisdictional. In addition the site contains approximately 2,288 linear feet of ditches that were determined to have been excavated out of uplands and to drain only uplands and were therefore determined to be non-jurisdictional.

Information submitted by the agent depicted uplands on site as having soils with greater than 30% uncoated sand grains and lacking indicators of hydrology.
