C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

 - Tributaries of TNWs where tributaries typically flow year-round are jurisdictional. Provide data and rationale indicating that tributary is perennial: **The project review area contains a feature that was determined to be a jurisdictional tributary**

with perennial flow. The tributary is man-made as it was excavated from uplands, has a concrete lined bottom and concrete stabilized banks. Although the tributary is concrete lined on the bottom and banks, it does have a defined bed and bank, an OHW mark, and has relatively permanent flow. Based on a review of topographic maps, soil survey information, as well as information in the file from a previous project that included the project review area and subject tributary, the feature is a re-located tributary named Captain Bills Creek. Upstream of the project review area, the tributary channel is visible in aerial photographs and flows through what appears to be wetlands. The tributary then enters a pipe that flows under E. Main Street and the Ralph Tuten Memorial Park for approximately 325 linear feet where it then becomes an open channel within the project review area. The tributary then exits the project review area and flows under James F. Taylor Drive and continues as an open channel flowing parallel to a pond crossing under Bailey Lane. The tributary continues downstream as an open channel and flows through an undeveloped area that appears to be wetlands. The tributary ultimately flows to Bees Creek and then the Coosawhatchie River, which is the TNW. The tributary was determined to have perennial flow due to flow being observed in previous site visits, the tributary being a named, blue line tributary on the topographic map, water being visible in the channel in aerial photographs as well as Google Earth street view photos, and that fact that the portion of the tributary within the project review area receives drainage from approximately 520 acres of wetlands and uplands. In addition, the box culvert at the downstream end of the portion of the tributary within the project review area is 6' X 5' in size indicating that a substantial amount of water flows through the tributary to downstream waters. On the upstream end of the portion of the tributary within the project review area, there is one 72" pipe coming from beneath the Ralph Tuten Memorial Park and two 48" pipes coming from beneath Blue Heron Drive. The box culvert and culvert pipe sizes indicate that water flow from upstream, through the project review area and to downstream waters is significant and supports a perennial flow determination. For these reasons, the feature within the project review area was determined to be a perennial tributary that is subject to regulation under Section 404 of the CWA.
