Summarize overall biological, chemical and physical functions being performed: **The 240 acres of adjacent wetlands provide habitat for terrestrial and aquatic wildlife, provide stormwater storage, water filtration, and ground water recharge. The waters not only provide habitat for various aquatic and terrestrial organisms, including a variety of insects, amphibians, reptiles, mammals and birds, but are also a source of food, nutrients, and carbon for organisms located downstream. The wetlands are especially important for the water quality within the watershed. The tributaries function to carry the hydrologic flow downstream. Water runoff from surrounding uplands that may contain pollutants, sediments, excess nutrients, etc., have the opportunity to be filtered out by the adjacent wetlands. Excess water can also be temporarily stored in the wetlands thereby minimizing potential flooding of downstream areas, and can also slowly release water downstream to maintain seasonal flow volumes. Water runoff transported within the tributaries may also contain healthy levels of organisms, nutrients, and carbon, which are needed downstream to maintain healthy ecosystems.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Documentation for the Record only: Significant nexus findings for seasonal RPWs and/or wetlands abutting seasonal RPWs: Tributaries 1-3 within the review area were determined to be seasonal RPW. These tributaries are surrounded by and share boundaries with 8.11 acres of wetlands. The 0.1 square mile drainage area of Tributaries 1-3 consists of forested area. The surrounding area outside the drainage area includes residential developments, an impoundment, and more forested areas. Tributaries 1-3 and their abutting wetlands provide a variety of functions that are important for the downstream waters and the watershed as a whole. The waters not only provide habitat for various aquatic and terrestrial organisms, including a variety of insects, amphibians, reptiles, mammals and birds, but are also a source of food, nutrients, and carbon for organisms located downstream. The wetlands are especially important for the water quality within the watershed. The tributaries function to carry the hydrologic flow downstream. Water runoff from surrounding uplands that may contain pollutants, sediments, excess nutrients, etc., have the opportunity to be filtered out by the tributaries and abutting wetlands prior to flowing further downstream. Excess water can also be temporarily stored in the abutting wetlands thereby minimizing potential flooding of downstream areas, and can also slowly release water downstream to maintain seasonal flow volumes. Water runoff transported within the tributaries may also contain healthy levels of organisms, nutrients, and carbon, which are needed downstream to maintain healthy ecosystems.

Watershed 03050201-05 (formerly 03050202-010, and a portion of -020) is located in Berkeley and Dorchester Counties and consists primarily of Cypress Swamp and its tributaries. The watershed occupies 139,162 acres of the Lower Coastal Plain region of South Carolina. Land use/land cover in the watershed includes: 52.5% forested land, 25.3% forested wetland, 14.4% agricultural land, 7.1% urban land, 0.4% nonforested wetland, 0.2% water, and 0.1% barren land. Williams Branch flows into Big Run and is joined by Black Creek to form Wassamassaw Swamp, which accepts drainage from Mill Branch, Caton Creek, and Simmons Bay. Partridge Creek (Rudd Branch, Mill Branch) joins Wassamassaw Swamp to form the headwaters of Cypress Swamp. Cypress Swamp receives drainage from Sandy Run (Smith Branch), Miller Dam Branch, Felder Branch, Dawson Branch, Stanley Branch (Kelly Branch), and Green Bay Branch near the Town of Ridgeville. Cypress Swamp then accepts drainage from Captains Creek (McKeown Branch), Platt Branch, Rumphs Hill Creek (Negro Branch), Tina Branch, Hurricane Branch, Bobs Lake, and Schultz Lake before flowing into the Ashley River watershed. There are a total of 357.9 stream miles and 219.7 acres of lake waters in this watershed, all classified FW. Givhans Ferry State Park is located at the base of the watershed. Aquatic life uses are fully supported; however, there is a significant increasing trend in five-day biological oxygen demand. Although dissolved oxygen excursions occurred, they were typical of values seen in blackwater systems and were considered natural, not standard violations. There is a significant increasing trend in pH. Recreational uses are partially supported due to fecal coliform bacteria excursions. <http://www.scdhec.gov/HomeAndEnvironment/Water/Watersheds/WatershedMap/>

Therefore, seasonal tributaries 1-3 and the abutting wetlands within the review area have a significant nexus to downstream TNWs as the tributaries maintain seasonal flow volumes and can transport organisms, carbon, and nutrients downstream. Also, see Section III.D.2 below regarding the seasonal flow within the tributaries.

Tributaries with groundwater influence allow for seasonal to perennial flow when rainfall is not present.**

- Wetlands directly abut RPW and thus are jurisdictional as adjacent wetlands.
 Wetlands directly abutting an RPW where tributaries typically flow year-round. Provide data and rationale indicating that tributary is perennial in Section III.D.2, above. Provide rationale indicating that wetland is directly abutting an RPW: **There are 7.256 acres of wetlands abutting a perennial RPW within the review area. The perennial RPW is located outside the review area flowing through the middle of the Cypress Swamp wetland system. The 7.256 acres of wetlands within the review area are a part of the Cypress Swamp wetland system. In other words, the 7.256 acres of wetlands continue offsite and are a part of a larger wetland system identified as Cypress Swamp. The perennial RPW runs through the Cypress Swamp wetland system. Therefore, the Cypress Swamp wetland system is abutting, surrounded by, and shares boundaries with the perennial RPW. Hydrologic flow runs from the 7.256 acres of wetlands within the review area through Cypress Swamp, into the perennial RPW, into a TNW. The 7.256 acres of wetlands within the review area which is a part of the entire Cypress Swamp wetland system that abuts the perennial RPW can be seen on the USGS topographic map, aerial photos on google earth pro, infrared maps, LIDAR, and hydric soils map.**
- Wetlands directly abutting an RPW where tributaries typically flow “seasonally.” Provide data indicating that tributary is seasonal in Section III.B and rationale in Section III.D.2, above. Provide rationale indicating that wetland is directly abutting an RPW: **The 8.11 acres of wetlands within the review area directly abut, are surrounded by, and share boundaries with season RPW tributaries 1-3. The 8.11 acres of wetlands also directly abut, are surrounded by, and share boundaries with the 7.256 acres of wetlands abutting a perennial RPW mentioned above. Hydrologic flow runs from the 8.11 acres of wetlands/seasonal RPW tributaries 1-3 into the 7.256 acres of wetlands, through Cypress Swamp, into the perennial RPW, into a TNW.**
