pockets surrounded completely by uplands. The wetlands are positioned lower in the landscape than the adjacent uplands. Based on a review of aerial imagery and LIDAR, as well as a site visit, there were no ditches, swales, or other linear features which would allow the conveyance of flow from the wetlands to the downstream TNW. No surface hydrologic connections between wetlands and waters of the U.S. were present. In addition, there is no apparent shallow subsurface hydrologic connection, and no apparent physical chemical, or biological connection to waters of the U.S. The wetlands also have no apparent ecological interconnection to waters of the U.S. For these reasons, Wetland 2 and Wetland 3 were determined to be isolated and non-jurisdictional and therefore not regulated by Section 404 of the CWA.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

C. SIGNIFICANT NEXUS DETERMINATION
