C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The area in review is comprised of 21.96 acres and includes 1.17 acres of isolated wetlands. This site is comprised of hydric Leon soils, which are hydric for Horry County. Wetland hydrology (inundation) was present within the boundaries of the isolated wetland. Horry county NWI data depict the site as PFO4B and PSS1/4A wetlands and U42P uplands. The isolated wetland is approximately 300 linear feet from the nearest WOUS (wetlands abutting Socastee Swamp) feature as depicted on USGS topographic maps and Google earth true color aerial imagery.

The isolated wetland has no connections to other Waters of the US (WOUS). Additionally, the site contains a single upland excavated non-jurisdictional ditch. Field inspection of the perimeter of the wetland yielded no visible connection and was surrounded by non-hydric soils, containing greater than 30% uncoated sand grains.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The area in review is comprised of 21.96 acres and contains 7.96 acres of jurisdictional wetlands and 780 linear feet of perennial RPW. This site is comprised of hydric Leon soils which are considered hydric in Horry County. Wetland hydrology (inundation) was present within the boundaries of the isolated wetland and jurisdictional wetlands. Horry County NWI data depicts the site as PFO4B and PSS1/4A wetlands and U42P uplands. Jurisdictional wetlands onsite abutt the onsite tributary known as Socastee Swamp which is represented on USGS topographic maps as a solid blue line, the symbol for perennial flow.
