- **B.** Typical year assessment(s): Antecedent Precipitation Tool (APT) data for typical year determination was calculated for the date the site was visited by the consultant (October 16, and November 13, 2019) and the dates the site was visited by the Corps (January 22, and July 28, 2020). According to the APT data, the October and November visits conducted by the agent were considered drier than normal to normal conditions, the January visit conducted by the Corps was considered to be wetter than normal, and the July visit conducted by the Corps was considered to be within normal conditions. The multiple site visits allowed for observation of hydrologic conditions the Corps considered to be within a typical year.
- **C.** Additional comments to support AJD: Request for AJD under the new Rule for a parcel that previously received a PJD (SAC-2019-1898) dated February 25, 2020.

The area in review contains approximately 9.18 acres and includes one excluded water. WA is encompassed entirely by uplands and lacks a direct or indirect surface connection to (a)(1-3) waters. The Corps has conducted two site visits (January 22, 2020 and July 28, 2020) on this parcel to determine the status of waters on-site. Since, WA does not abut an (a)(1-3) water, is not inundated by an (a)(1-3) water, and is physically separated by more than a single artificial barrier, it is determined to be an excluded water.
