jurisdictional. Wetland B is 0.75 acre and is surrounded by uplands and is positioned lower in the landscape than the adjacent uplands and had no linear features coming out of the wetland. The surrounding uplands slope into Wetland B with no outlet for the water that collects there. No evidence of discrete surface hydrologic connections through the uplands to other waters of the U.S. was observed. There was also no apparent shallow subsurface hydrologic connections, and no apparent physical, chemical, or biological connections, to waters of the U.S. In addition, the wetland had no apparent ecological interconnection to waters of the U.S. For these reasons, the wetland was determined to be isolated and non-jurisdictionl, and, therefore not regulated by Section 404 of the CWA.



#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW.
