If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

photography, appears as a blue line tributary on USGS quadrangle maps, is a named tributary, and based on a review of USGS quadrangle map, the drainage area of Penny Creek may be approximately 14,000 acres or more in size, and may contain several thousands of acres of wetlands, thus supporting perennial flow. In addition, based on the FEMA's Flood Map Service, some of the wetlands abutting Penny Creek are within the 100 Year Flood Plain. For these reasons, Penny Creek likely has perennial flow and was thus determined to be a perennial RPW. At some point downstream of the confluence of Penny Creek and Adams Run, Penny Creek becomes a TNW and tidal before flowing into the Edisto River.

A review of offsite information including Soil Survey, aerial photographs, and NWI maps indicate that an offsite wetland system is present and that it is contiguous with Penny Creek and Adams Run. LIDAR indicates that the land elevation between the subject property and Penny Creek decreases from approximately 25 feet at the subject property to approximately 14 feet or less at Penny Creek. LIDAR indicates that the wetlands located on the subject property are located at or below approximately 29 feet. In addition, FEMA's Flood Map Service also shows that some of the offsite wetlands are within the 100 Year Flood Plain and are listed as being Zone AE with a base elevation of 8 feet. Based on a review of this information, the wetland located onsite is part of a large wetland system that extends offsite and is contiguous with Penny Creek; therefore, the onsite wetland is considered to be directly abutting the RPW (Penny Creek).**
