C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Chemically this system of wetlands capture and filtrate pollutants, sediments, and excess nutrients from surrounding forestry, agricultural, and civil activities. Biologically these wetlands provide a diversity of habitat for wetland dependent and non-dependent species. They provide and abundance of habitat for nesting and foraging as well as a travel corridor by its cover and canopy. As primary producers, these wetlands inject a significant contingent of biomass into the foodweb.

A man-altered, named tributary (Horse Savannah) is represented by a solid blue line on USGS topographic maps, indicating flow at least 90% of the year. A site visit in 2009 during the height of the growing season found flowing water with an OHWM, clearly defined bed and banks, channel free of vegetation, and a firm channel bottom. Additionally, a review of aerial photography, Soil Survey data, National Wetland Inventory data, and a site visit depict a well-defined channel with near constant flow indicating conditions for this tributary are similar to initial observations.

absorption / treatment of nutrients, runoff, and pollutants. Physically, the topographic location of these wetlands and their relation to other jurisdictional waters of the US is such that water in wetlands 4 and 5 are retained and eventually percolated through the soil to groundwater only, to an unknown depth, providing little if any stormwater attenuation.
