does not flow directly or indirectly into a downstream TNW. No surface or shallow subsurface connection from the wetland to another waters of the U.S. was evident during the site visit or could be found after a review of aerial photography, soil survey information, NWI maps, LiDAR maps, and topographic maps. All water contained within the wetland is retained within the wetland boundaries and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetland was determined to be isolated non-jurisdictional and not connected to any other waters of the U.S. The onsite wetland was also determined to have NO substantial nexus to interstate (or foreign) commerce.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

A site visit was conducted on December 2, 2016. The entire site was walked and determined to consist mostly of uplands. However, the Northwest corner of the site was determined to be wetlands. The wetland area consisted of hydrophytic vegetation, hydric soils, and indicators of hydrology were observed. The northwest corner of the site is mapped on the NWI as Palustrine Scrub-Shrub Wetland. This area had indicators of hydrology and was determined to be wetlands. However, the wetlands and waters on site do not flow into a Traditional Navigable Water and were determined to be isolated, non-jurisdictional. No surface or shallow subsurface connection from the wetland to another waters of the U.S. was evident during the site visit or could be found after a review of aerial photography, soil survey information, NWI maps, LiDAR maps, and topographic maps. All water contained within the wetland is retained within the wetland boundaries and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetland was determined to be isolated non-jurisdictional and not connected to any other waters of the U.S. The onsite wetland is also approximately 165' from the closest non-jurisdictional ditch and is separated by non-hydric soils and a berm adjacent to the ditch. The onsite wetland was also determined to have NO substantial nexus to interstate (or foreign) commerce.
