This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Documentation for the Record only: Significant nexus findings for seasonal RPWs and/or wetlands abutting seasonal RPWs: The seasonal RPW located along the northwestern property boundary is performing a variety of functions that related to the physical, chemical, and biological integrity of the TNW. The physical characteristics of the tributary include performing flow maintenance functions such as retaining runoff from the adjacent agricultural fields. Flow maintenance results in the reduction of downstream peak flows, which help to maintain seasonal flow volumes. Functions of the tributary that impact the chemical integrity of the TNW downstream include the filtering of excess nutrients contributed by runoff from the surrounding uplands due to agricultural practices, which reduces nitrogen and phosphorus loading downstream. A variety of biological functions are being performed by the seasonal RPW, which include providing breeding grounds and shelter for aquatic wildlife and foraging areas for water dependent species and other wildlife. This tributary provide diversity through vegetation changes, and where the aquatic system adjoins the adjacent uplands. Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the traditional navigable water of the Reedy River, it has been determined that there is a significant nexus between the relevant reach of the tributary to the downstream TNW.

Stream characteristics observed and available data led this office to conclude the tributary has a seasonal flow regime.**
