B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: A desktop review was conducted for this jurisdictional determination. The entire site (2.07 acres) was determined to consist of uplands. The consultant submitted maps, data sheets, and photographs to support this determination. In

addition, the Corps reviewed the best available information to determine jurisdiction to include (aerial photos, topo maps, soil survey information, NWI maps, LiDAR maps, and Hillshade maps). After researching the above-mentioned information, the Corps determined that there are no wetlands or other waters of the United States present on the site. Topographic maps do not depict any wetlands or tributaries (i.e. blue lines) within the site boundaries. NWI maps depict the site as uplands. Soil survey maps depict the entire site as non-hydric soils (Eulonia and Wahee). LiDAR maps do not suggest any wetlands or tributaries on site.
