soil. Therefore, no surface or shallow subsurface connection, from the wetland to another waters of the U.S. was evident during the site visit or could be found after a review of aerial photography, soil survey information, NWI maps, and topographic maps. All water contained within the wetland is retained within the wetland boundaries and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetland was determined to be isolated non-jurisdictional and not connected to any other waters of the U.S. Topographic maps do not depict any wetland symbols or tributaries (i.e. blue lines) within close proximity to the subject wetland. There is a series of man-made non-jurisdictional ditches that traverse the property. However, the closest ditch to the isolated wetland has approximately 50'-60' of a natural upland barrier between the ditch and wetland boundary. The onsite wetland was also determined to have NO substantial nexus to interstate (or foreign) commerce.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Water was flowing within the tributary at the time of the site visit. The tributary flows within the boundaries of the onsite wetland.

The isolated wetland on this site is assessed on JD Form 1 of 2.
