determined to be uplands. This area is depicted on a map in the file dated January 2015 and entitled "Goretown Mine / Horry County, SC". After the site visit on December 9, 2015, it was determined that the area in question did not exhibit hydric soils or hydrology. More than 30% uncoated sand grains were observed in the upper 6" of the soil profile and no indicators of hydrology were present. The soil exhibited no saturation and no oxidized rhizospheres along living root channels. According to the WETS table and recent rainfall data, this area was approximately 15-20 inches above normal rainfall during the site visit. In addition, approximately 200 acres of large mine pits area located north of and directly adjacent to the subject property which may be causing drainage effects on the nearby wetlands.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

In addition, approximately 200 acres of large mine pits area located north of and directly adjacent to the subject property which may be causing drainage effects on the nearby wetlands.
