## C. SIGNIFICANT NEXUS DETERMINATION

Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). **B.** ADDITIONAL COMMENTS TO SUPPORT JD: Based on a review of the aerials, topographic map, soil survey, NWIs and information submitted by the agent, the site was determined to be void of aquatic resources. The aerials depict this site as cleared

agricultural fields. A data point submitted by the agent on site shows that this area does not contain hydric soils or indicators of hydrology. The topographic map depicts this site as cleared uplands, and the soil survey maps this site as Eunola, which is partially hydric. The NWIs map this site as upland agricultural fields (U21). Therefore, this site was determined to consist entirely of uplands.
