Explain: **Potential wetlands on-site were examined during a site visit conducted on 2/10/16 and determined to lack indicators of hydrology during a period of above average rainfall and therefore do not meet the required criteria set forth in the 1987 delineation manual for identification of a wetland.**

One non-jurisdictional ditch is located along the northwest project boundary. This feature was observed during a site visit conducted on 2/10/16 during a period of above average rainfall. The feature lacked sinuosity, was filled with leaf litter, and contained large amounts of fibrous and woody roots from the surrounding upland and Fac vegetation. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The feature lacked sinuosity, contained a buildup of leaf litter, and large amounts of fibrous and woody roots from the surrounding upland and Fac vegetation.
