**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

visible from aerial imagery and during the time of the September 8, 2016, site visit, had flow. The offsite pRPW provides drainage to a large area and has been channelized to provide stormwater drainage for an adjacent railroad and flows into the pRPW Church Creek which flows into the Ashley River, a TNW. During the site visit, evidence of recent beaver activity was seen including recently chewed saplings and a partially constructed dam. For these reasons it was determined that the feature had perennial flow. The unnamed pRPW forms the southern boundary of the project area.
