**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

feet north of the on-site wetland. During the site visit, the Corps was able to examine tributary and observed that it was flowing with water and appeared to show signs that the stream flows year round based on the amount of water flowing through. Additionally, the creek is a named tributary and is a solid blue line on the USGS Topography map.

Wetlands Area 4 as described on the plat is a fairly large wetland that abuts McCaskill Creek to the north. While McCaskill Creek is not within the project area, it is approximately 70 feet to the furthest north point of the project area. During a site visit on June 2, 2017, the Corps was able to observe from the project area that the wetland continues all the way to McCaskill Creek. Additionally, data from the NWI, USGS Topography survey, and Kershaw County LiDAR data all indicates that this wetland is a large complex that abuts McCaskill Creek to the north and northwest of the site. McCaskill Creek showed evidence that water does flow year round as it had a large amount of water flowing during our site visit and is documented as a solid blue line with abutting wetlands on the USGS Topography survey.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD: This JD form documents the jurisdictional status of one wetland directly abutting a perennial RPW (McCaskill Creek). Based on guidance provided, wetlands that abut perennial RPWs are waters of the U.S. and within jurisdiction of the Clean Water Act.**
