was included in a previous jurisdictional determination (SAC-2013-01237) issued on February 6, 2014. The previous jurisdictional determination, which remains valid until February 6, 2019, determined the wetland to be isolated non-jurisdictional and not subject to regulation under Section 404 of the CWA. The subject wetland continued offsite and was present on the adjacent parcels (TMS# 279-00-00-618 and 279-00-00-180). However, based on a review of the current aerial photographs, the portion of the subject wetland that was included in the previous jurisdictional determination (SAC-2013-01237) has been filled for construction of buildings and a parking lot. The subject wetland is surrounded by uplands, is positioned lower in the landscape than the adjacent uplands, had no ditches, swales, or other linear features coming out of the wetland, and there was no evidence of a discrete surface hydrologic connection through the uplands to other waters of the U.S. There was also no apparent shallow subsurface hydrologic connection, and no apparent physical, chemical, or biological connection, to waters of the U.S. In addition, the wetland has no apparent ecological interconnection to waters of the U.S. For these reasons, the wetland was determined to be isolated and non-jurisdictional, therefore not regulated by Section 404 of the CWA.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
