- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The review area consists of three (3) isolated, non-jurisdictional wetlands (Wetland A - 5.7 acres, Wetland B - 3.8 acres, Wetland C - 1.7 acres). The three wetlands were observed in the field by the consultant and observed by the Corps utilizing the best available information (i.e. aerial photography, topographic maps, soils survey information, NWI maps, and LiDAR). The wetlands were determined to be surrounded on all sides by non-hydric soils which disrupt any hydrologic connection between the wetlands and any other waters of the U.S. In addition, no ditches, swales, or tributaries can be observed in or near the wetlands to convey water to downstream tributaries. The topographic map depicts a blue line (i.e. linear conveyance) in or near the vicinity of Wetland B. However, after researching the consultants submittal and aerial photographs and LiDAR information, it was determined that the conveyance (i.e. blue line) does not exist. All water contained within these wetlands is retained within the wetland boundaries and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, these wetlands were determined to be isolated non-jurisdictional and not connected to any other waters of the U.S. The onsite wetlands were also determined to have NO substantial nexus to interstate (or foreign) commerce.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The three (3) depressional areas onsite were determined to meet the three parameters for the identification of a wetland as outlined in the 1987 Corps Manual. However, it appears that water that enters the wetlands is confined within the wetlands and leaves only through evaporation or percolation to an unknown depth. As mentioned above, no drainage patterns, ditches, or tributaries were observed outside of the onsite wetlands. The onsite wetlands were determined to be isolated, non-jurisdictional.
