**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 3 acre tract in Conway, SC. Present on site are 0.23 acres of jurisdictional wetlands directly abutting a 193 LF jurisdictional RPW. USGS topographic survey information depicts a mostly cleared forested area with the wetland symbols present in the eastern portion of the boundary, a solid blue line present. The upland portion of the project area is mapped as Echaw a non-hydric soil. The wetland area of the project boundary is mapped as the hydric soil Leon. NWI maps show the majority of the project area mapped as uplands (U42P) and wetland area is mapped forested wetland (PFO1/4C). The wetland evaluated in this determination is contiguous and abuts an on-site unnamed perennial RPW. .**
