- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: A potential wetland was depicted on the topographic map, soil survey and NWIs as being located on the northern portion of the site. This area is depicted as a Carolina Bay on the topographic map and is mapped Pantego, a hydric soil, on the soil survey. It is depicted as a palustrine forested wetland on the NWIs. Data points taken by the agent in this location, as well as information obtained during the site visit, show that this area has hydric soils and hydrophytic vegetation. However, no indicators of hydrology were located in this area or on site. Based on the information submitted by the agent and information obtained during the site visit, this site was determined to consist entirely of uplands.

A linear feature was also observed within the project boundary. This feature is not depicted on the topographic map or aeriels. Terrestrial vegetation and dry leaf litter and debris were observed within this feature and spoil piles were located on either side of this feature. This feature was determined to be a non-jurisdictional ditch. .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
