This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area consists of 7.91 acres of wetlands and 367 acres of uplands. A site visit was conducted on 4/23/2014 to confirm the presence of wetlands within the project area. The locations of the wetlands observed on site were in agreement with the USGS topographic survey information, Marion County Soil Survey, and NWIs. Inundation and soil saturation were observed within the wetlands during this site visit. Wetlands were determined to abut Green Swamp Creek. Green Swamp Creek drains into the Pocatoligo River. The Pocatoligo River enters the Black River at R.M. 107.7. Green Swamp Creek is depicted on USGS topographic maps as a solid blue line which is the symbol for water with at least perennial flow. Green Swamp is depicted on USGS topographic maps as contiguous and abutting Green Swamp Creek. The NWI depicts the wetlands within the project area as palustrine forest and the Sumter County Soil Survey depicts the soils within those wetlands as 100% hydric. Based on the above referenced site visit, a review of aerial photography, USGS topographic information, Sumter County soil survey information and NWI maps, there are no observable natural or manmade barriers to obstruct the direct hydrological, chemical and biological connection between the wetlands within the project area and the off-site pRPW. .**
